

Good Afternoon Mayor Gillingham,

The Assembly of Manitoba Chiefs (AMC) is dedicated to preserving the lives and memory of First Nations citizens who died in Residential School Institutions, particularly those in the St. Norbert area where a recent research project suggests a high likelihood of a mass unmarked grave.

A research group has shared their findings with AMC staff, revealing a potential mass unmarked grave on the property of the Behavioural Health Foundation, Lemay Forest, and the City of Winnipeg.

The site holds historical significance dating back to the early 1900s when the Misericordia Sisters operated the L'Aisle Ritchot orphanage. In the late 1940s and early 1950s, the Oblates took over the property for use as a seminary.

We take this news very seriously and our hearts go out to the family and Nations of these little ones who were not given the opportunity to return home, even after they died. It is with heavy hearts, but solid determination, we will seek to repatriate these little ones so they can be laid to rest in the care of their loved ones.

Over the past two weeks, the AMC has gathered information and data, including digitized archives from the Societe Historique de Saint Boniface, to shed light on this historical tragedy. Collaboration with John Wintrup Planning Development and Tochal Development Group has been crucial in initiating this research project.

Research conducted by the Peguis Consultation and Special Projects Office Archaeological and Heritage Group confirms the presence of a cemetery at Aisle Ritchot, containing both individual and mass graves dating from 1907 to 1918. Approximately 1500 burials, mostly in mass graves, include infants without parents or families without means for individual graves. Records also indicate hundreds of deaths are likely linked to the Sisters of Misericorde hospital.

However, the exact cemetery location remains unknown. Non-invasive testing in both the development boundaries and the cleared area west of them is needed. To ascertain the cemetery's size and the presence of human remains, a comprehensive survey program is necessary, utilizing test-pits, ground-penetrating radar, resistivity, and magnetometry tests, all focused on locating graves without disturbing the ground.

It's important to note that Lemay Forest owners lack full control over nearby properties suspected of unmarked mass graves.

It is the intent of the AMC to actively collaborate with other property owners to ensure collective action is taken to ensure this testing takes place.

As such, the AMC is asking the City of Winnipeg to hold off on any development in this area in order to investigate the presence of unmarked mass graves.

In closing the AMC is committed to engaging with various levels of government for completion of this work. Specific methods for the search are under discussion, with a strong focus on employing the least invasive techniques possible.
